1 THIS MATTER having come on regularly before the undersigned judge of the above-  
2 entitled Court; and the Plaintiff, Kaylee Tennyson, acting by and through their attorney David P.  
3 Moody, Hagens Berman Sobol Shapiro LLP, and the Defendant, State of Washington, and its  
4 agency, the Department of Social and Health Services, and represented by their attorney Steven L.  
5 Abel, Assistant Attorneys General; and these parties having reached a stipulation pursuant to  
6 RCW 4.92.150, settling and compromising and allowing for dismissal of this action with prejudice  
7 against the State with a full release of those claims, and it appearing to the Court, after a review of  
8 the files and records herein, that the sum of Seven Hundred Fifty Thousand and No/100 Dollars  
9 (\$750,000.00) and waiver of State liens in the amount of Three Hundred Forty-One and 21/100  
10 Dollars (\$341.21) is a proper and just settlement to be paid by the Defendant, State of Washington,  
11 Department of Social and Health Services to the plaintiff and the Court being fully advised, now,  
12 therefore,


13 IT IS HEREBY ORDERED that the Plaintiff, Kaylee Tennyson, shall have judgment  
14 against the Defendant State of Washington, Department of Social and Health Services for the total  
15 sum of Seven Hundred Fifty Thousand and No/100 Dollars (\$750,000.00) and waiver of State liens  
16 in the amount of Three Hundred Forty-One and 21/100 Dollars (\$341.21).

17 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that neither party shall  
18 recover against any other party their respective fees, costs, nor interest herein.

19 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, pursuant to the  
20 provisions of RCW 4.92.160, the Defendant, State of Washington, shall pay to the clerk of the  
21 above-entitled Court the sum of Seven Hundred Fifty Thousand and No/100 Dollars (\$750,000.00)  
22 for the benefit of the Plaintiff and that upon receipt of said sum the clerk thereof shall forthwith  
23 dismiss this case with prejudice, satisfy the judgment against the State of Washington, Department  
24 of Social and Health Services and shall mail a check made payable to "David P. Moody in Trust  
25 for Kaylee Tennyson" to the following address: David P. Moody, partner, Hagens Berman Law


